Mike Joyce '86



Mike Joyce attended St. Cajetan Grammar School and graduated from Leo High School in 1986. At Leo Mike served on the Student Council, was a National Honor Society member as well as Class Salutatorian and played starting center on Leo's first State Playoff football team, coached by Bob Foster.

At Leo Mike also began boxing following in the footsteps of his south side hero, "Irish" John Collins (Leo '79 and Chicagoland Sports Hall of Famer). Joyce continued boxing throughout college.

After graduating from Chicago's St. Xavier University, Mike had a brief professional boxing career, before attending law school at John Marshall.

During Law school, Mike Joyce volunteered as an assistant coach for Leo high School under Mike Holmes, in 1995. In 1998, at the urging of President Bob Foster, Joyce revived the boxing program for Leo High School, which was begun by the great Bob Galloway.

With the help of old time boxing greats, Eddie Perkins, Luther Rawlings, and Herman Mills, Leo's boxing program produced many Golden Gloves Champions and received much recognition. The Illinois State Crime Commission has designated Leo Boxing Club as its model Police Athletic League program, because of its focus on our youths' success in life.

Mike Joyce continues to coach the Leo Boxing Team and has served on the Leo Advisory Board since 2000.

Mike Joyce is the son of Mary and Jeremiah Joyce. He is the proud husband of Jamillah and father of Nadia and Amira.

Brother Charles C. McKenna, CFC '54



Charles C. McKenna graduated from Our Lady of Peace Grammar School and entered Leo High School in 1950.

While at Leo, Chuck was a member of the Glee Club, the Legion of Mary, and the Propagation of the Faith. He was a member of the Class of 1954.

Chuck earned a B.A. from Iona College. He continued his education and earned a M.A. degree from Saint Xavier University. He also took courses at Gonzaga University, Holy Name College, DePaul University, Loyola University, University of Detroit, and Mercy College. Brother McKenna has been assigned to schools in California, Victoria B.C., Seattle, and Detroit areas as well as 38 years at St. Laurence High School in Burbank, Illinois.

In addition to his teaching responsibilities, Chuck has ministered to the poor and homeless at the St. Pius V Soup Kitchen on South Ashland Avenue in Chicago for the past 14 years until the present time. Until a year and a half ago, Brother recruited students to serve and directed the distribution of food at the Soup Kitchen. Since his illness, Brother is involved in the recruiting of students for service and makes the directional presentation to the students before they leave school to go to the Soup Kitchen. Chuck also directs a daily volunteer prayer gathering of St. Laurence students.

Brother McKenna celebrated 57 years as a Christian Brother in 2010. He is a member of the Leo High School Alumni Association and taught Summer School at Leo several times during the 1970's.

Chuck's hobby is going to downtown Chicago, especially Millennium Park, Navy Pier, the Water Tower area and Oak Street Beach.

2011 Community Service Award

Curtis Cooper '75



Always involved in sports since his grade school days, Curtis Cooper consistently showed his peers that he had what it took on and off the field to excel. He attended St. Helena Elementary School, and as a student at Leo Catholic High School, he was a standout scholar and athlete.

"I played football and was named athlete of the year in my senior year," Cooper says. "Afterwards, I attended the University of Illinois at Urbana-Champaign and played football there. I had fun playing sports, but it was off-the-field time that I found very rewarding."

Cooper was interested in marketing and obtained a bachelor's degree in business administration, with a concentration in marketing. After graduation, he went from downstate Illinois to north suburban Gurnee. Six Flags Great America wanted him in their Corporate Sponsorships Department. He spent six years getting many accounts for the amusement park, then decided to move into a different arena within the industry.

Selling for those five radio stations paid off year after year. He generated the most revenue, earning Cooper the distinction of President's Club winner for three years. He was the top of his game, but after a while, sports came back into the picture, and he found a way to merge his love for the game with his business acumen. He decided to delve into sports marketing and joined the Chicago Bulls in 2007 as a senior account executive of corporate sponsorships. His nearly three-year tenure there has been challenging, yet very rewarding; he shares with enthusiasm in his voice.

While he makes his living calling on others to write a check for the Chicago Bulls, he signs his fair share in his personal time. Many organizations have been the benefactor of his and his wife Dawn's generosity, including the United Negro College Fund, the NAACP, the Make-A-Wish Foundation and the American Heart Association.

Cooper also gets involved with his community. He is a consultant for LaRabida Children's Hospital, has coached an elementary school girl's basketball team for a few years, and has been involved with Big Brothers Big Sisters. His high school alma mater also gets a taste of his marketing skills as he is on the school's Fundraising Committee.

When he is away from work, Cooper enjoys spending time with his wife and daughter Courtney.

2011 Hall of Fame

Richard M. Finn '71

Rich came to Leo from Little Flower Parish in 1967. He was one of six Finn brothers to attend Leo High School. He played football all four years and was captain both his freshman and senior year. His senior year the team won the South Section. He was voted 1st team All-Catholic and president of his Senior Class.

Upon graduation from Leo in 1971 he attended Brown University Providence R.I. He played football all four years at Brown and received the prestigious Frederick S. Broomhead Award. The rigorous qualifications state that the recipient must be the football player whose continuous and generous contributions to Brown Athletics and loyal devotion to the University promise to make him an ambassador of Brown traditions and values for the coming years.

After college he spent his entire business career in Sales. He spent 25 years with McDonnell Douglas/Boeing Capital. Through an acquisition he worked for GE Capital for five years and retired as Senior Vice President in March 2009. In retirement, Rich spends several days a week driving for the American Cancer Society taking patients to their treatments.

He lives in Tinley Park with his wife Patty, and they have two sons and two daughters.

Bill Hession '54

His is a story like many other South Siders of his generation: the son of Irish immigrants who lived in an apartment just off 79th street; raised Catholic; educated at Little Flower grammar school and then on to Leo High School, where his life was truly transformed.

His name is Bill Hession and he is a Leo man through and through.

In fact, because of Leo and coaches like Bill O'Neill and Jim Arneberg, Bill developed into a skilled quarterback and basketball player, being named "best athlete" his senior year—an especially impressive feat, considering he stands only 5-foot-8. This acumen earned him a full scholarship to Loras College where he was influenced by another mentor, Father Edward Sullivan.

Upon graduating, Bill did not seek fame or fortune. Instead, he returned to his South Side roots to do what he knew he could do best: teach, coach, counsel, and mentor.

For more than 40 years, Bill quietly influenced the lives of his students this way, first at Leo and the Leo Boys Club, then at Reavis High School and Moraine Valley Community College.

The three greatest words a teacher can hear are "because of you." Over the years, Bill has been blessed to hear those words:

"Because of you, Mr. Hession, I became a nurse..."

"...a teacher"

"...a coach."

"...a counselor."

Indeed, Bill's life has come full circle by influencing the lives of many, including his four children, nine grandchildren, and his wife of 54 years. He is an ordinary man, but one who leads an extraordinary life through *facta non verba*—and that has made all the difference.

Jack Hogan '42

Jack came to Leo from St. Sabina Parish. While at Leo, Jack was on the honor roll, played basketball and was involved with the intramurals. One of his fondest memories was playing on the St. Leo CYO team and winning the championship.

Jack entered the army in June of '43 and served until February of '46. During WW II, he served in Europe with the field artillery. Since his outfit served with many divisions, his most memorable combat experience was being in the Battle of the Bulge while attached to the 101st Airborne. After the war, he attended Loras College and completed his studies at Loyola.

After college he began a career in the printing business, working for Moore Business Forms for 37 years, retiring as their Sr. Account Representative. Jack enjoys his retirement, by singing and acting. He has been involved in many plays throughout the Midwest.

Jack has been to 58 Leo banquets; he was the chairman of the Silver and Golden Jubilee classes; he volunteers to sing at funeral masses for Leo Alumni and in 1962 his musical group sang at the banquet which was held at Halleran's on 95th Street. Jack said recently that at age 87, he is going to continue singing until he gets it right.

It can be said that Jack has brought more joy and happiness to more people than most of us could only dream of.

He married his wife Peggy, in 1949 and they have three children; Michael, Kevin and Ellen.

Thomas W. Lynch '73

Thomas W. Lynch is a member of Leo Class of 1973. He came from St. Mary Star of the Sea. While at Leo Tom was a member of the Student Council, the library and the track and cross country teams. He used those talents to help secure a scholarship to De Paul University. Tom graduated from De Paul in 1977 and shortly thereafter passed the CPA exam.

Tom worked for the Internal Revenue Service and continued his education at John Marshall Law School until he received his law degree. He passed the Bar in 1986 and went to work in the Illinois Attorney General's office. Tom presently heads up his own law firm out of Hickory Hills, Illinois. Tom has been a very proactive member of our Alumni Association for over 10 years. He has served as an officer for the last 4 years. Tom has also been recognized as a previous Leo Man of the Year award recipient.

Early on, Tom saw the need for the Alumni Association to have a website. He conceptualized such a site which allows alumni to review the history of the school, record their personal experiences, interact with other alumni and take care of business relating to the school. Tom has followed up on his promise to take the steps necessary to further develop the website.

These steps have included recording important current events of interest to Alumni and sponsoring, and working on a series of articles, ("Alumni Stories") on individual alumni which help capture the experience of being part of Leo High School. Tom continues to work on providing Leo Alumni a state of the art website.

Rear Admiral William E. Newman '57

Bill entered Leo from St Barnabas Grammar School. While at Leo, Bill sang in the glee club, splashed in the pool, and got 'religion' about studies from Brs. Hennessey and Stoehr.

A member of the Leo swim team all four years, he was voted Captain his senior year. As his Leo years ended, Bill received an appointment to the United States Naval Academy, from which he graduated with distinction in 1961. As a Navy varsity swimmer, Bill made NCAA All-American in 1960. Following Annapolis graduation and Navy pilot training, Bill served the next twenty years as a carrier-based fighter-attack pilot, also performing duties as a Navy test pilot and Flight Leader of the Navy's *Blue Angels*. He logged a career total of 5000 pilot hours and 900 carrier landings in 50 types of U.S. and British military aircraft. During combat missions over North Vietnam, Bill's A-4 "Skyhawk" was hit by enemy ground fire on several occasions, including being shot down and rescued on a 'lucky' Friday-the-13th. During 1978-79, as Commanding Officer and Flight Leader of the Navy's *Blue Angels*, Bill led formation aerobatics during 200 air shows throughout the USA and

Canada along with numerous public appearances at schools and civic organizations across the nation.

Following the *Blue Angels*, Bill had overall command of the nine squadrons comprising the air wing of the aircraft carrier *USS Constellation*, operating in the North Arabian Sea during the U.S. Embassy hostage crisis in Tehran, Iran. He then served as Captain of *USS White Plains*, a 17,000-ton combat re-supply ship operating in the Pacific and Indian Oceans.

Promoted to Rear Admiral, Bill served the latter years of his 35-year career as a Navy Materiel Professional. His responsibilities included management of a joint-service guided missile program, engineering oversight of Naval Aviation acquisition programs, and command oversight of the Navy's research and test activities performed on 53,000 square miles of flight test ranges in Southern California and adjacent Pacific Ocean.

Bill resides with his wife, Susan, in Kirkland, Washington, near Seattle.

Benjamin Jerome (Iggy) Richards '41

Benjamin Jerome (Iggy) Richards was born in Chicago on January 15, 1922 to Ben and Maise Richards. He graduated from St. Columbanus Grammar School in 1937 and followed his brother Elmer to Leo High School. He attended Leo on a basketball scholarship with his dad Ben at every game.

As Captain of the 1941 Lightweight Championship Team, he was chosen as the "All Tournament Player" in the Fenwick Tournament and "All Catholic Player" of the Catholic League. He went on to play ball at Loras College for his former Leo Coach Vince Dowd with several of his Leo teammates.

In 1942 he left to serve in World War II. Following the war he married Virginia Zimmerman and they raised seven children who all attended Catholic Grammar and High Schools. He is the proud Grampa of 22 and recently became a Great-Grampa. He is one of the original members and a former Vice President of the Leo Alumni Association and served on its original Alumni Scholarship Committee.

Tom Spatz '51

Leo's basketball season came to an early and disappointing end on Wednesday, Feb. 23, when the Lions lost to Chicago Christian 53-51 in the semifinals of the Class 2-A Regional at Chicago Christian. Leo was looking forward to a rematch with Catholic League rival Hales for the regional championship, but couldn't get past the host team in the semifinals. The game was close throughout, but the Knights made eight straight free throws in the final minute to secure the win.

Leo finished 16-12 in the final season for seniors Maurice Joiner, Paul Beene, Josh Gilbert, Derrius Brown, Chris Tarleton and Mike O'Donnell. The highlight was an amazing five-overtime victory over Brother Rice on Alumni Night at Leo on Jan. 14, but things took a turn for the worse after that. Hales took advantage of Leo's tired legs and raced past the

Lions one night later. The following week, the discovery of plaster damage in our 85-year-old gym forced the Lions to hit the road for more than three weeks---three games had to be rescheduled, and a scramble for practice time took Leo to St. Xavier, St. Sabina and St. Margaret of Scotland, often for 6 a.m. sessions when that was the only gym time available. Mr. Fuller's construction crew did a wonderful job of repairing the damage and getting the gym painted and spruced up for Senior Night on Feb. 18, but Mount Carmel spoiled the party by avenging the loss it had suffered to Leo at home in the Catholic League opener back in December.
